**RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT**

In consideration of the Swiss Society of Vancouver accepting my application for membership and permitting me, my family members and guests to take part in the activities of the Swiss Society and of the various associations and clubs within the Swiss Society, I hereby agree as follows:

TO WAIVE ANY AND ALL CLAIMS that I and my family have, or may in the future have against the Swiss Society, and its directors, officers, volunteers, operators, agents, representatives, successors and assigns (all of whom are hereafter collectively referred to as "the releasees"), and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I and my family may suffer or that my and my family's next of kin may suffer resulting from my and my family members' and guests' participation in the activities of the Swiss Society, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT, RSBC 1996, C.337 ON THE PART OF THE RELEASEES, AND ALSO INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME AND MY FAMILY MEMBERS AND GUESTS FROM THE RISKS, DANGERS AND HAZARDS OF THE ACTIVITIES OF THE SWISS SOCIETY REFERRED TO ABOVE; TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of or personal injury to any third party, resulting from my and my family members' and guests' participation in the activities of the Swiss Society;

This agreement shall be effective and binding upon my and my family's heirs, next of kin, executors, administrators, assigns and representatives, in the event of my or my family members' death or incapacity;

This agreement shall be governed by and interpreted in accordance with the laws of the province of British Columbia; AND

Any litigation involving the parties to this agreement shall be brought within the province of British Columbia. In entering into this agreement I am not relying upon any oral or written representations or statements made by the releasees with respect to the safety of the activities of the Swiss Society other than what is set forth in this agreement. It is understood and agreed that this agreement shall not apply in respect of injuries or death resulting from gross negligence, or malicious or willful misconduct.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I, MY FAMILY MEMBERS, GUESTS, HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.
